## Compliance and Indemnity Agreement and Signature

- I (we) the undersigned, have read the Rules and Regulations of the Canal Street Marketplace Farmers' Market and do agree to abide by all rules and regulations, including but not limited to insurance requirements.
- I (we) further agree to operate my (our) stall in accordance with these rules and regulations and to pay all applicable fees as set out in the rules and regulations. I (we) do understand that the stall fee, length of season, and hours of operation are set in the rules and regulations, and I (we) will abide by them.
- I (we) further understand that failure to comply with the rules and regulations of the Village of Fort Edward Canal Street Marketplace could mean dismissal from the market.
- As a vendor, wishing to participate in the Farmers Market, I (we) agree to SAVE, HOLD HARMLESS and INDEMNIFY the Village of Fort Edward Canal Street Marketplace, the Village of Fort Edward, members and employees from any and all liability or responsibility pertaining to any damages to person or property on the site assigned to me (us) by the Village of Fort Edward Canal Street Marketplace, when such damages or liability arise out of acts on my (our) own, or of my (our) employees or associates, located as such site. Such agreement for INDEMNITY, RELEASE AND HOLD HARMLESS includes claims by third parties and including reasonable attorney fees incurred by the Village of Fort Edward, Village of Fort Edward Canal Street Marketplace, its agents, employees and other exhibitors in defense of such claims. This agreement to RELEASE AND HOLD HARMLESS AGREEMENT may not be changed orally.
- I (we) verify that all information I (we) have provided about my farm and products for sale is true and accurate and that I am operating under all of the proper New York State, Federal and Local certificates necessary to sell my products and hereby further agree to abide by any State, Local and/or Federal Laws pertaining to selling my products at the Village of Fort Edward Canal Street Marketplace.
- I (we) understand that the Village of Fort Edward Canal Street Marketplace operates on limited funds. I (we) also acknowledge that the Village of Fort Edward Canal Street Marketplace's beneficial purpose will be impossible to pursue if it is subjected to costly litigation. Wherefore I (we) hereby agree that as a condition of my participation in the Village of Fort Edward Canal Street Marketplace, I (we) will resort to litigation against the Village of Fort Edward Canal Street Marketplace, its officers, management, and affiliated entities, only after attempting in good faith to resolve the dispute. I (we) will limit any claim I (we) may have as a result of a decision by the Village of Fort Edward Canal Street Marketplace management, steering committee or Board of Directors which results in the denial of a market acceptance, the denial of a product to sell, or wrongful suspension or termination from the Village of Fort Edward Canal Street Marketplace, to a return of market fees incurred during my (our) absence from the market. I (we) further agree that in the event I (we) am/are unsuccessful in my (our) litigation against the Village of Fort Edward Canal Street Marketplace, I (we) will pay all costs, expenses, fees, and disbursements incurred by the Village of Fort Edward Canal Street Marketplace in the course of its defense of said litigation, and I (we) will also pay the Village of Fort Edward Canal Street Marketplace a reasonable attorney's fees.
- I (we) agree and understand that the Village of Fort Edward Canal Street Marketplace makes no representations and/or warranties as it relates to profitability and understand it is our responsibility to maintain all our own business records, file taxes and keep track of individual income.

- I (we) agree and understand that by filling out this application there is no guarantee that there will be space for me at the Marketplace and that scheduling and availability is at the sole discretion of the Village of Fort Edward Canal Street Marketplace and their management team and/or Board of Directors.
